

**87FSS FAMCAMP RULES**  
87FSS Outdoor Recreation (ODR)  
Bldg. 6045 Doughboy Loop,  
JB MDL Dix

1. Check-out is no later than 1100 hours. Check-in is any time after 1300 hours. Campers are required to first report to 87FSS Outdoor Recreation (Bldg 6045) prior to occupation of the 87FSS FamCamp site, unless noted otherwise by 87FSS Outdoor Recreation staff members. If you arrive after 87FSS ODR is closed, please call 609-562-6667 and leave a message alerting us to your arrival.
2. Site may not be sublet. Only one Recreational Vehicle is allowed per site.
3. A registration sign issued by 87FSS ODR must be displayed clearly in a window of the RV so it can be easily seen from the FamCamp road.
4. Quiet hours are between 2100-0800 hours. Please be considerate of your neighbors.
5. Generators **MAY NOT** be used **AFTER** 2100 hours or **BEFORE** 0800 hours.
6. Park in designated and assigned areas only. **DO NOT** park personal vehicles in un-assigned RV spaces, as this hinders paying customers from occupying their reserved sites.
7. Speed Limit is 5 miles per hour within the FamCamps.
8. Washing of RV's and personal vehicles is not permitted in the campground, as per JB MDL Environmental Regulations. Hosing down engines, getting soap on the ground, sweeping or washing out of battery compartments at the 87FSS FamCamp sites are also prohibited.
9. Dumping gray/black water on the ground is prohibited. Campers must utilize sewage dumpsites or hook-ups.
10. Bicycle helmet use is mandatory on JB MDL.
11. Campfires are allowed only in provided fire rings. A fire extinguisher **must** be obtained from Outdoor Recreation (if not personally owned) and be at the fire ring when a campfire is lit. To ensure camper and Rod & Gun patron safety, campfires are **PROHIBITED AT ALL TIMES** at the Range 14 FamCamp location.
12. Campers must fully extinguish charcoal embers from personal grills and dispose of ashes in the proper receptacle by the dump station.
13. The outside area of your RV must be kept neat and orderly at all times and meet the visual standards of JB MDL. The site must be kept clean and free of trash. **DO NOT** put household garbage in the litter receptacles located adjacent to the 87FSS FamCamp. Campers must use the 5 yard dumpster.
14. Mats, rugs, canopies, grills, clotheslines, clothes racks, etc are permitted on the outside of RV's. Campers are responsible to frequently move items to avoid damage to the grass. Outdoor Recreation reserves the right to determine the visual appearance of each site and notify campers accordingly.
15. Children are the sole responsibility of their parents or guardian.

16. Operating ATV's, dirt bikes or any off-road vehicles is prohibited.
17. Vehicle maintenance or repairs are **NOT** permitted at the site. Fluids may be added to vehicle for preventative maintenance but **NOT** drained. Freon maintenance, break change, shock replacement, jacking of vehicle, tire change, oil change, etc is **NOT** permitted. 18. Upon departure, campers must police the RV site to ensure that it is returned to its original condition.

## **PET POLICY**

Campers must comply with the following in the presence of pets:

1. Pets must be on a leash **AT ALL TIMES** when outside and are **NOT** to be left outside unattended. Owners must be in their own space with their pet if they are to be leashed outside the RV. A tie down leash must **NOT** exceed 6 ft. or reach neighboring space/water faucet.
2. Pets must have all immunizations up to date. Owners are responsible for having immunization records readily available on site.
3. Pet owners are responsible for ensuring their pets do not disturb others with constant barking, walking of pets through other spaces or barking during quiet hours.
4. All pet droppings **MUST** be picked up and properly disposed of immediately
5. Pets are **NOT ALLOWED** in the shower/bathroom facilities.
6. Guests failing to comply with the Pet Policy will be required to leave the 87FSS FamCamp at the discretion of 87FSS ODR Staff.
