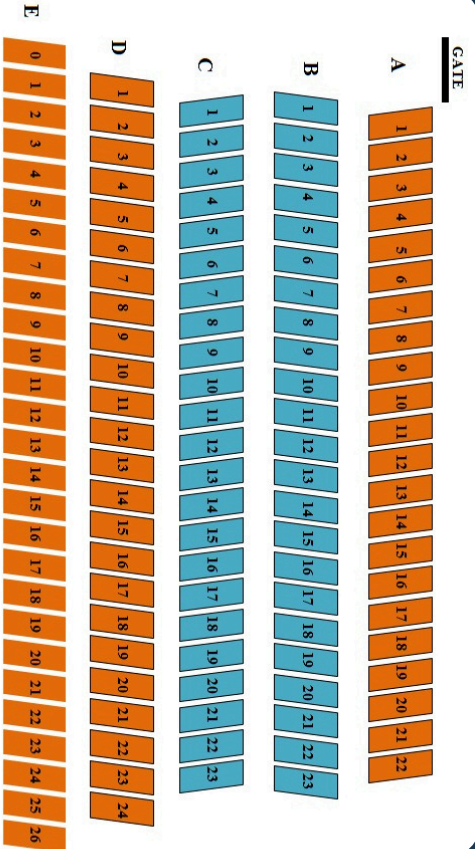

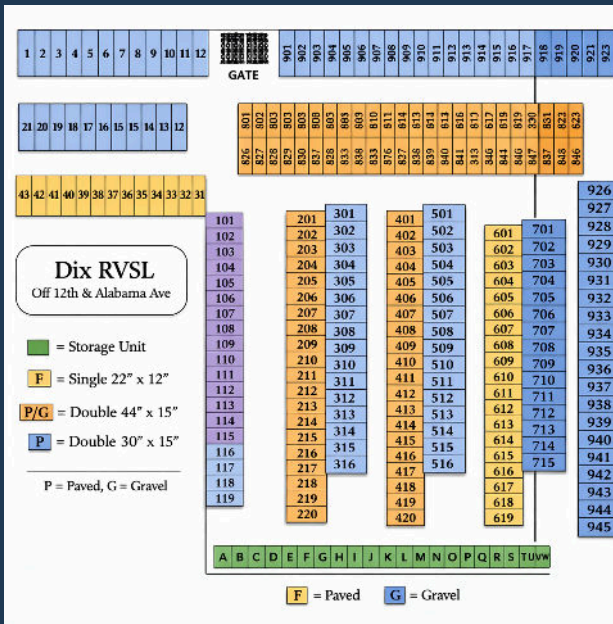

Storage spaces will not be leased to customer until all required documents are on file.

Fees

Our office charges guests based on a yearly fee. Fees will be charged at the beginning of each calendar year (CY) using our RecTrac 3.1 System. RecTrac 3.1 encrypts clients credit/debit cards and will only be charged when a bill is run. Particiaption in the RecTrac 3.1 system is required to store an item in our lot. If clients are assigned a space after the new year has begun the rate goes as follows: Remaining Months of CY x *Monthly Fee. This fee will be charged in full at the beginning of the following month after assigned

Policies

- ✓ Stored items must be parked within the confines of their assigned space only. Parking in a different space may result in immediate contract cancellation.
- ✓ Stored items must remain entirely within the assigned space—inside the white side lines and the imaginary line across the opening—and may not extend onto the grass or into another customer’s spot.
- ✓ Stored items must remain operational at all times with tires properly inflated.
- ✓ All stored items must be registered and insured in accordance with IAW OI 34-101-2.
- ✓ State registration/tags must be current and permanently mounted. Only Active Duty members may maintain out-of-state registration; all others must register in New Jersey.
- ✓ State registration/tags must be current and permanently mounted. Only Active Duty members may maintain out-of-state registration; all others must register in New Jersey.
- ✓ Liability and comprehensive insurance must remain current.
- ✓ Watercraft must be stored on a trailer.
- ✓ Minor maintenance (e.g., bulbs, tires, cleaning) is permitted if it does not impact adjacent spaces.
- ✓ Major maintenance (e.g., oil or coolant changes, motor or brake work) is prohibited.
- ✓ Major maintenance (e.g., oil or coolant changes, motor or brake work) is prohibited.
- ✓ Vehicles must be securely chocked to prevent movement or damage; lightweight plastic chocks are not recommended.
- ✓ Storage spots may not be changed or transferred, and access codes may not be shared; violations may result in investigation and revocation of storage privileges.
